- **6. Data Retention** Data is retained for the time necessary for the above purposes and in any case no longer than:
 - 10 years for tax and accounting obligations;
 - 24 months for marketing purposes (unless consent is revoked);
 - 12 months for browsing data.

- Payment service providers (PayPal, WIX Payments, Apple Pay, Google Pay);
- Shipping carriers for order delivery (DHL, UPS, Poste Italiane, LKW, Fercam);
- Tax and legal consultants;
- Competent authorities in case of legal obligations;
- Marketing and web analytics platforms (Google Ads, Meta Ads).
